BACKGROUND/SUMMARY:

The County of Imperial Administration Office has allocated \$97,033.00 for FY 2022/2023. The below expenditure plan was developed in connection to the grant requirements. To accept this grant funding, the City is required to adopt a resolution accepting the funds and an expenditure plan outlining the use for those funds. (See Resolution 2024-53)

Expenditure plan outlines the following Public Safety expenditures.

- 1. \$8,569.00: (2) Recon Interceptor E-Bikes
 - E-Bikes will be fully outfitted at GSA pricing, and will be purchased upon approval.
- 2. \$47,467.15: (1) 2025 Ford Explorer Active
 - · Vehicle will be for support services, and purchased upon approval.
- 3. \$22,785.64: (2) EZ-Go Golf Carts
 - Golf carts will be used at the High School, and Frank Wright to assist SRO's and minimize time traveling
 from one side of the campus to the other. Golf carts will be purchased upon approval.
- 4. \$1,218.39: (1) Snap Charge Locker
 - Locker will be used to assist in keeping electronic devices charged when taken as evidence, thus preserving evidence which may be in the device. Locker will be purchased upon approval
- 5. \$2,089.89: (10) Ballistic Helmets
 - Helmets will be issued to Officers, and ordered upon approval
- 6. \$396.00: (2) Soft Protective Helmets
 - Helmets will be used from subjects attempting to injure themselves. Helmets will be purchased upon approval.
- 7. \$10,006.39: (24) Ceramic Plate Carrier with Plates
 - Plate carriers will be issued to Officers, and purchased upon approval.
- 8. \$3,739.78: (20) Vortex Binoculars
 - Binoculars will be issued to patrol, and purchased upon approval.
- 9. \$760.76: Drone replacement parts
 - Replacement parts will be purchased on an as need basis.


