SUBJECT: DISCUSSION/ACTION TO ACCEPT BID SUBMITTED FOR THE CONSTRUCTION OF THE SAVANNA RANCH RETENTION BASIN FENCE.	
DEPARTMENT INVOLVED: COMMUNITY SERVICES	
BACKGROUND/SUMMARY: On February 12, 2019, City Council provided direction to seek estimates for the building of a 420 foot section of a 6 foot tall wooden fence along the east side perimeter of the Savanna Ranch Retention Basin.  On March 6, 2019, City Council approved bids to be sought for a commercial grade privacy chain link fence to replace the previous fence not to exceed \$14,000.00.  Two bids were received in the amounts of \$17,652.50 and \$20,115.50. Staff conducted a study of the companies and proposals; staff recommends the acceptance of AB Fence Company, Inc. bid in the amount of \$17,652.50.  Please see attached bid proposal and bid results.
