DISCUSSION/ACTION: RENTAL OF SYNTHETIC ICE SKATING RINK FROM EMERALD EVENTS

1. AUTHORIZATION FOR RENTAL OF SYNTHETIC ICE SKATING RINK FROM EMERALD EVENTS FOR IMPERIAL MARKET DAYS ON DECEMBER 14, 2019 FROM 5 PM TO 9 PM;

BACKGROUND/SUMMARY:

The City of Imperial will be hosting its Imperial Market Days event within city limits on Saturday, December 14, 2019 from 5 PM to 9 PM. As an attraction feature for December, staff was directed to secure the rental of an ice skating rink for this event. The ice skating rink will be located in front of the NAPA parking lot during the Imperial Market Days and Parade of Lights event, as a free recreational activity to the community.

Emerald Events is the company that will be providing a 32x72 synthetic ice skating rink for the December Imperial Market Days Event. Emerald Events has identified the cost to be \$13,150 for the set-up, tear down, and preparation of the of the ice skating rink. The cost also includes 120 pairs of assorted ice skates, fencing, and all necessary equipment.

Emerald Events has provided a Certificate of Insurance, naming the City of Imperial as additionally insured, and will provide a waiver for each participant to sign before entering the ice skating rink. - 1) If you have not already done so, please sign and return the event agreement with your deposit.
- 2) We need about 40ft X 40ft (or 10ft more than the size of your booked Rink) of very level, even unobstructed non-abrasive surface area with easy drive up access. If you have any obstacles or debris in the area, please remove prior to our arrival. The rink is very heavy and we cannot bring up steps or hills. We need to be able to drive right to setup location with our trailer. We cannot operate on grass, dirt, uneven concrete/tarmac, plush carpet or any surface that has bumps, debris or imperfections. The rink needs to lay on completely flat surface only.
- 3) You will need to print out our waiver and have a waiver signed for each person participating.
- 4) Polite and friendly team member(s) will arrive at the agreed time. We will arrive approx. 60-240mins before the event to setup (depending on Rink size) and will be around for approx. 60-120mins after the event to teardown. We will need lights and electric power for the full duration.
- 5) Please have the area in which we are to operate clean and free of all objects/debris/ waste etc. If the area is not clean on arrival, there will be an extra charge incurred and we may not be able to operate.
- 6) There are absolutely no street shoes, sharp objects, food or drinks allowed inside the rink area.
- 7) No one under the influence of Drugs or Alcohol or who is suffering from any medical condition that could cause a danger to themselves or others should participate. Participants should only participate if they are healthy enough to do so. All participants and on-lookers must follow all instructions and listen to the crew member's instructions. Anybody acting in an unsafe or disruptive manner will not be allowed to participate.
- 8) We request access to 1 X standard 110v power outlets and a hose bib for water if possible.
- Safety is our primary objective and your co-operation in ensuring the safety of all guests is appreciated.
- 10) We do not always supply fencing but it is required. If you did not book fencing through us, you will need to supply fencing unless agreed previously.
- 11) Ice Skating can be dangerous and patrons participate at their own risk. We are not responsible for any injuries, loss, damage or mishaps that occur while on the rink or while in the changing area or surrounding areas. Helmets are not supplied.
- 12) Take lots of pictures and videos.
- 13) Tips are graciously accepted by the team members who work very hard to make it a fun event.
