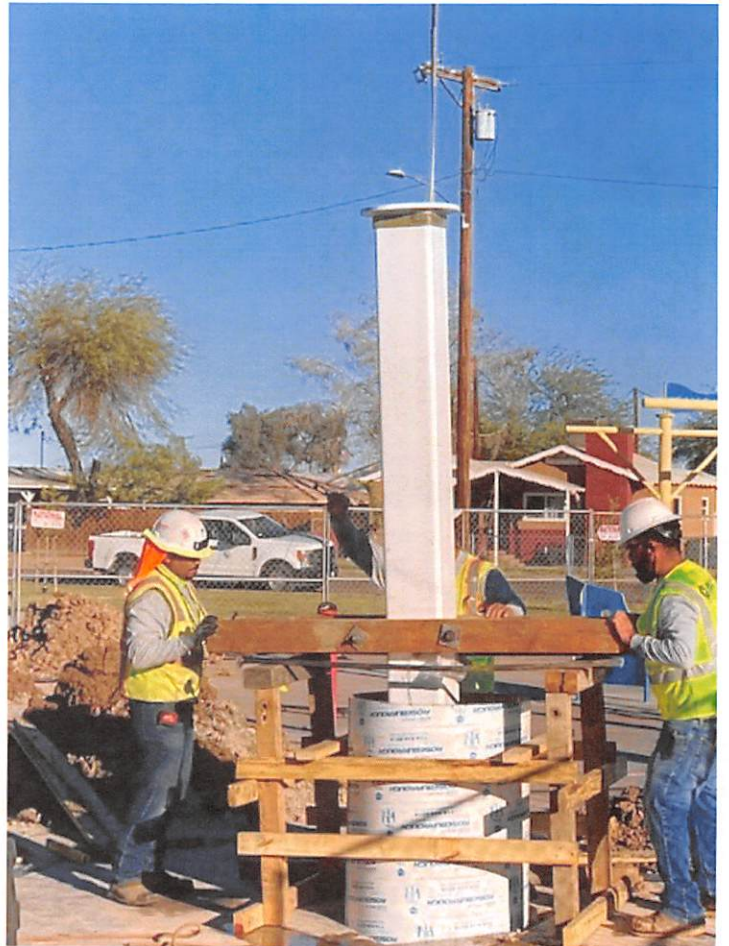

BACKGROUND/SUMMARY: In the Summer of 2021, City Council awarded the contract for Eager Park Splash Pad Project to USA Shade in the amount of \$121,485.24. This was one of the projects identified to be funded by the Per Capita grant awarded to the City of Imperial through Prop 68. The City conducted its final walkthrough of the project and it was deemed complete on November 15, 2021. The project did have a change order that was generated due to water table conditions in the amount of \$6,837.60; the project total being \$128,322.84. Staff is requesting City Council accept this project as “complete” and allow the filing of Notice of Completion. Please see attached.
