Loper presented the staff report. Burnworth, the new one will be purchased, will the current one be repaired and become the backup? Loper, yes. Amparano, what is the time frame we are looking at? Loper, we will not know the time it will take until we order the parts and they give us an expected delivery time.

Mora presented the staff report. Amparano, is this for the striping? Mora, it's for the thermo plastic bike lane, the design. Amparano, so this is to ensure the project is completed correctly. Is this something we can do in house? Mora, that is correct. At the current time we do not have the capabilities to take care of this inhouse. In the future, we will be able to take care of this in house. Burnworth, do you have a professional engineer to stamp the completed plans? Mora, we do not, and for this project we would not need it since there are no significant changes. We also have consultants on hand we can hire if needed.

F-5. <u>Subject:</u> Improvements to Sunset Park

Discussion:

Lopez presented the staff report with a power point. Amparano, I like the red clay. What would that do to the DG that we put in there? Lopez, we would need to regrade the area first, then install additional drain boxes. This will help keep the new improvements from deteriorating. Tucker, where does the water go after the storms? Lopez, with the grade working properly, it will go to the southeast corner. Currently it's not working properly it needs to be regraded. Currently the water just pools. We want to install 12x12 suction boxes with a regrading this will allow us to pump the water out right away. Amparano, does this price include the materials, labor, and regrading? Lopez, we would be working with Public Services to complete this as an in-house project. If needed we can also look to our non-profit organization for help with donations of labor work if there is work that would need to be outsourced. Dale, is there a way we can get some lights installed? Lopez, Public Service has sent me the cost for the past installed lights. I know we will have funds to do some extra things, like the lights. Dale, I can buy the light in a pair on Amazon for \$600.00. I would buy the lights and donate them if they could be put on a pole and mounted just so the kids and those wanting to use the park when its dark out can. Lopez, we will have some extra funds and have some options that we can look into for this. Loper, if you can get me the specification of the lights I can look in to what we can do for installing lights.

F-6. <u>Subject:</u> Community Development Department Safety Standards.

Discussion:

Mora presented the staff report. Amparano, how is the code enforcement officer protecting themselves? What are we doing to take care of them? I have had this conversation before with Mr. Morita. I ask what is being done for the staff's safety. Morita, although data has been collected on situations that a code enforcement officer would face,

ultimately, it's up to us at the end of the day on what measures to implement. According to our information, we do not have anything that would put our code enforcement officer in danger. The PD would be engaged if a situation would arise. My recommendation is to proceed with a non-tactical uniform: a polo shirt and pants. This may change in the future with new data. Amparano, what do ICC, CA, and CEO stand for? Mora, International Code Counts, and the California Association of Code Enforcement Officers. Amparano, how much training does our staff have? We give them all the training, but nothing to protect themselves. Dale, I don't believe the code enforcement officer should escalate the situation; if it gets to the point where it's escalating, the PD should be involved. I am all for education on both sides. I have an issue with the word officer on the title code enforcement; when someone thinks they are an officer when they are not, it can create issues when they approach someone. This creates escalation.
